- 22/00487 Change of use and subdivision from bank to one retail unit and one hair, beauty and tanning studio including alterations to street frontage with new glazing and entrance door to provide separate access to each unit and wrought iron fence to front at Former NatWest 71 – 73 Newbegin, Hornsea
- 22/00339 Fell 1 no. Sycamore tree (T1) due to major concern over structural integrity as the tree is a poor specimen and a neighbouring Sycamore in close proximity has recently blown over in high winds leaving this specimen now exposed to the elements at The Pillars, 32 Westgate, Hornsea
- 22/00338 Crown reduce 1 no. Horse Chestnut (T1) by removing 2 no. large over extended limbs which are overhanging the main road and public footpath over concerns for the structural integrity due to a main limb already shedding in the high winds at White Tree, 1 Northumberland Avenue, Hornsea
- 22/00249 Erection of single storey extension to side following demolition of existing porch and store at 26 Tranmere Park, Hornsea
- 21/04394 Erection of a dwelling with car port and access through an existing gate/entrance and associated works at Land South West of Southorpe Lodge, Hull Road, Hornsea
- 22/00570 Pollard 1 no. Plum tree (T1) back to main stems as the tree is in extremely close proximity to a brick outbuilding and has now reached the scale where there is major concern over structural integrity to the building at Redstacks, Atwick Road, Hornsea
- 22/00581 Crown reduce 2 no. Sycamore trees by 3 metres to match the crown reduction of trees at neighbouring property at 16A Eastbourne Road, Hornsea
- 22/00569 Cheyne Walk and Hollis Recreation Ground, pollard 1 no. Ash tree – to pollard back to the main stems as the tree has shed large limbs in recent high winds and is causing a major concern over structural damage to the property – crown reduction 1 no. Oak tree – to reduce the crown by 1.5 metres as the tree is heavily leaning towards the property, there are concerns over the tree failing due to the heavy lean and weight in the crown at 6 Cheyne Garth, Hornsea

- 21/04530 Fell 1 no. Eucalyptus tree in rear garden as it is outgrowing its position. Crown reduce height of small birch trees in front garden by 2 metres at 7 High Bow, Hornsea

Holly tree (T3) due to the tree being a poor specimen and in close proximity to the garage raising concerns over structural damage at Holmlea, The Leys, Hornsea
