> T1 - Young multi stemmed sycamore x 4 stems forming part of self seeded tree line on the boundary to the rear of the property. T2 - Young ash forming part of self seeded tree line on the boundary to the rear of the property T3 x10 young sycamores, forming part of self seeded tree line on the boundary to the rear of the property The trees are to be removed from the boundary as all the trees are poor/weak specimens, the majority of which have swallowed a chain link fence in to the main stems at Farberry Seaton Road Hornsea

> T1 Sycamore crown lifting of up to 6m of lower limbs/branches to make the tree more aesthetically pleasing and to allow more light in to the garden at White Tree, 1 Northumberland Avenue, Hornsea

> T1 Corsican Pine to reduce/remove limbs encroaching on to the property; to remove the risk of damage. T2 Corsican Pine to remove the 2 larger limbs which are overhanging the private lane on Football Green to reduce the weight and risk of potential failure at Moresco, Football Green, Hornsea

> Outline – Erection of a dwelling (all matters reserved) following removal of outbuilding at Land South West of 15 Queens Gardens, Hornsea

> Outline – Erection of 2 dwellings (means of access to be considered) (revised scheme of ref 17/01988 OUT) at Land South of Lapstone, The Leys, Hornsea T1 Multi stemmed sycamore to section fell to ground level due to the tree being in a poor form and weak structural integrity. T2 Cedar to crown lift up to 6m to allow more light in to the garden and to improve the aesthetics of the tree at 15 Burton Road, Hornsea

> Alterations a extensions including erection of a 2 storey extension and refurbishment/remodelling of existing leisure centre to provide new multipurpose facility including library, customer service centre, social services centre, enhanced leisure facilities, café and other ancillary services with associated external works including improvements to hard and soft landscaping, service areas and car parking following demolition of existing single storey kiosk buildings at East Riding Leisure, Hornsea Broadway,
