- 3 **Town Clerk's Update**
- a) Horizon Parking Activity Report August  
The Deputy Clerk informed members of the PCN & Activity Report for August received from Horizon Parking. There had been 3 tickets issued all of which had been paid. **NOTED**
- 4 **Bird Boxes Hall Garth Park**  
An E-mail had been received from Mr C Reed, representative of the Grounds and Gardening group at the Hollis Recreation Ground regarding a bird box project scheme where pupils of the Senior School along with Yorkshire Wildlife Trust made bird boxes some of which had been sited at the Hollis ground. More boxes were available and approval was being sought from members for these boxes to be sited in Hall Garth Park for mid to late October ready for the Spring. It was **APPROVED** that the offer be accepted and the boxes be placed in suitable places within Hall Garth Park and if possible Elim Lodge Gardens and a letter of thanks be sent to Mr Reed.

**5 Application for use of Hall Garth Park 2019**

Mr R Prince, TWP Catering, asked for members approval for the use of Hall Garth Park during the school holidays and weekends throughout the year, weather permitting, to put a small food bar and bouncy castle in the area at the bottom end near to the children's play area to commence from Easter 2019. It was agreed that a) ERYC be contacted regarding whether rates would be charged b) ERNLLCA be contacted to get their opinions and c) following the feedback from ERYC and ERNLLCA the matter be taken to the Parks & Cemeteries Working Party for further discussion.
