Sycamore tree (T003) due to vehicle damage to main stem and is leaning. Fell 1 no. Sycamore tree (T004) due to co-dominant stem and included bark in union. Fell 1 no. Sycamore tree (T007) due to tree being in decline, decay in union of branch framework and high percentage of deadwood. Fell 1 no. Sycamore tree (T002) due to poor shape and form. Fell 1 no. Ash tree (T018) due to tree being self-sown. Fell 1 no. Beech tree (T027) and 1 no. Ash tree (T045) due to poor shape and form. Fell 1 no. Ash tree (T035) due to tree being self-sown and has poor shape and Fell 1 no. Maple tree (T036) due to poor form and decay form. pockets in main stem. Fell 1 no. Ash tree (T037) due to large fungal fruiting bracket present at bas of main stem. Fell 1 no. Beech tree (T040) due to poor shape and form, second stem dead and weak union at split. Fell 1 no. Ash tree (T041) due to tree showing signs of dieback. Fell 1 no. Ash tree (T053) due to cavity at the base with decaying fungi present, necrosis and splitting of bark, and close proximity to and overhanging dwellings. Fell 1 no. Beech tree (T054) due to poor shape and form, necrosis of bark and fungi present at base of stem. Fell 1 no. Beech tree (T059) due to damage to bark of main stem and poor shape and form. Fell 1 no. Maple tree (T062) and 1 no. Ash tree (T066) due to close proximity to dwelling, poor shape and form, and reported problems by neighbour of poor television signal and possible damage to aerial and building. Fell 1 no. Ash tree (T067) due to tree displaying signs of advanced dieback. Fell 1 no. Ash tree (T071) due to dieback being present and poor shape and form. Fell 1 no. Sycamore tree (T095) due to dominant stem damage, decay evident at union and poor shape and form at Hollis Recreation Ground, Westwood Avenue, Hornsea.
