4 Hornsea Carnival – Request to use Hall Garth Park

Hornsea Carnival formally requested the use of Hall Garth Park between Thursday 19th to Monday 23rd July 2018 to hold this years Hornsea Carnival celebrations. **RESOLVED** the request be granted

5 Mereside Play Area Redevelopment

Councillor Ms J Kemp spoke to members regarding the redevelopment of Mereside Play Area. Following the discussion it was agreed that the Town Clerk seek further funding to enable the wetpour surface colour to be green, it was **RESOLVED** to accept the recommendations of the working party and that the chosen contractor, Streetscape, be appointed.

6 Hornsea Civic Society – Tree Planting Scheme – Hall Garth Park

Councillor Ms J Kemp spoke to members regarding the tree planting scheme for Hall Garth Park. She had met with Alan Tharatt, Civic Society following which a detailed scheme had been produced; members were informed that the planting would not be able to be carried out until around October as it was too late in the year for new trees to be planted. Councillor Ms J Kemp discussed the removal of the Willows at the far end near the play area to be removed by the contractors who are working on the new skate park. Councillor Ms J Kemp asked members to accept the scheme in principal with the view of further discussions taking place nearer the time for planting. It was **RESOLVED** that a) the scheme be accepted in principal, b) that the Willows be removed and c) that a meeting of the working party be arranged later on in the year for further discussion to take place.

7 Cinema Street Car Park

Councillor Andrew Eastwood informed members that a resident of Hornsea had approached him regarding Cinema Street Car Park and the congestion that arises getting in and out of the car park. Councillor A Eastwood suggested that a solution to the problem may be to remove the last 4 parking bays and make the car park one way. Members agreed that although they thought that it was a good idea in principal they did not feel that this would resolve the problem and asked that the item be deferred to allow the working party to meet following which the item would be included on a future agenda.
