- 6. **Police issues/attendance**  
The Chairman welcomed the Hornsea PCSO's to the meeting. Following information given on recent crimes in the town the Chairman thanked the PCSO's for their attendance
  
- 7. **Town Clerk's Update**
  - i) **Tree Survey – to consider an offer to finance the survey** – the Town Clerk informed members that T Whitehead (Arboriculturist) had offered to split the cost of a tree survey over 2 financial years – **RESOLVED** noted pending the receipt of further quotations
  - ii) **Town Centre summer planting/hanging baskets** - the Town Clerk commented on the impressive summer hanging basket/flower display
  
- 8. **Correspondence**

- 9. **ERYC Standards Board Hearing – to receive a recommendation**  
Information from ERYC having been previously circulated it was **RESOLVED** that Hornsea Town Council accepts the recommendation of the Standards Hearing. Cllr K Himsworth stated that it was never his intention to cause offence and made a public apology
  
- 10. **ERYC – proposed speed limit reductions**
  - i) **Westgate**
  - ii) **Eastgate and Cliff Road**It was **RESOLVED** that, in relation to the above items, a representative of the ERYC Highways be invited to the next meeting to clarify reasons for speed restrictions as proposed
  
- 11. **S137 Grant Funding – Westwood Avenue – to receive a recommendation from the General Purposes Working Group**  
Following the receipt of a recommendation from the General Purposes Work Group it was **RESOLVED** that a request for funding not be supported
  
- 12. **Mayoral/Deputy Mayoral election/nomination - to receive a recommendation from the General Purposes Working Group**  
Following a recommendation from the General Purposes Working Group it was **RESOLVED** that in future the Mayor be confirmed at the February Town Council meeting each year and the Deputy Mayor be nominated at this time also
  
- 13. **To receive recommendations from the Parks and Playground Working Group on:-**
  - i) **Skate Park** – Following the receipt of recommendations from the Parks and Playgrounds Working Group it was **RESOVLED** that:-
    - a) Action taken to arrange an operational safety check at the skate park be supported
    - b) Staff continue to monitor the skate park on a daily basis (not weekends)

- c) Should any emergency situation arise in relation to the skate park equipment then the Town Clerk will call and emergency meeting to discuss the matter
  - d) A quotation to carry welding repairs to skate park ramps not be implemented until the operational safety check report is received and/or unless this matter is specifically raised in the report
  - ii) **Bandstand Memorial Gardens** - Following the receipt of recommendations from the Parks and Playgrounds Working Group it was **RESOVLED** that:-
    - a) Any additional requests for use other than the Hornsea Lions be submitted to the Council for consideration – each application to be treated on its own merits
    - b) Access to electrical point(s) be kept locked and utilised at the discretion of the Council
  - iii) **Elim Gardens** - Following the receipt of ideas from the Parks and Playgrounds Working Group it was **RESOVLED** that once funding levels are established firm plans for any redevelopment etc be submitted to the Parks and Cemeteries committee for approval
  - iv) **Mereside** - Following the receipt of recommendations from the Parks and Playgrounds Working Group it was **RESOVLED** that designs and quotations be sought for a new play scheme at Mereside
