- iii) Parking area Cinema Street Car Park the Town Clerk confirmed that ERYC had very kindly provided "hatched" markings to the area to the front of the electricity sub-station in the Cinema Street car park free of charge **RESOLVED** noted

9. Hanging Baskets at the Greenway 2019

15. Elim Gardens – access from "The Park" residential home

The Town Clerk read an email from The Park residential home requesting pedestrian access into Elim Gardens from the rear of the residential home and emergency vehicle access through bollards at the main entrance. It was **RESOLVED** that both requests be denied

The Town Clerk gave details of two possible future projects – extension of the road in Edenfield Cemetery and upgrade of facilities at the Esplanade Depot. Following discussion is was **RESOLVED** that a working group meeting be convened as soon as possible to progress the road extension at the Edenfield Cemetery and a meeting be convened early in 2019 to discuss the Depot and other future projects
