9. Budget/Estimates/Precept 2019/2020

Draft estimates and budget notes having been circulated the Town Clerk gave additional details. Following considerable discussion it was **RESOLVED** that:-

- i) The precept demand for 2019/2020 be £384006.00
- ii) SHED Grounds Maintenance be appointed as the grass cutting contract for 2019 at a cost of £18123.28
- iii) The following capital expenditure projects be implemented during 2019/2020:
 - a) Survey costs etc in relation to drainage and new road way at Edenfield Cemetery £7000.00
 - b) Development of Town Hall Kitchen and toilet facilities at first floor level £29274.24
 - c) Purchase of an electric powered vehicle £4950.00
 - d) Remainder of funding required to complete the CCTV/ANPR upgrade £3317.70

10. Beacon

A report having been circulated and further information given by Cllr K Nicholson it was **RESOLVED** that a proposal for the Fire Brigade to take over ownership of the Beacon be supported in principle subject to further dialogue with the Fire Brigade, receipt of written confirmation from ERYC that the beacon is not their responsibility and a suitable transfer of asset document between Hornsea Town Council and the Fire Brigade being drawn up and signed/agreed by both parties

11. Public Space Protection Order (PSPO) review

12. Cinema Street Car Park – letter of complaint
