There was one letter of objection to this application which was circulated. Following discussion it was **RESOLVED** that this application NOT be supported due to:-

- i) Inadequate parking provision in an already problematic area
- ii) Overdevelopment of the site
- iii) Great concern was expressed in relation to the major effect this proposed development would have on the neighbouring property, particularly the proposed two storey extension to the rear and the fact that this appears not to have been taken in to account by the applicant within this proposal

#### 17. Lets Go Hornsea

#### 18. Hornsea Area Regeneration Partnership

Cllr B Y Jefferson reported the following:-

- i) The South Promenade redevelopment is progressing well and on time. The framework for the boat shed has been erected and the compound users are very happy with it
- ii) The Hornsea Leisure Centre redevelopment is progressing well and the secondary school murals have been chosen
- iii) The Hornsea Pottery Trail phase 1 is completed and it is hoped that the "tree" on the roundabout outside Tesco is as successful as the "fish tiles" on the Market Place roundabout
- iv) It is hoped that the "chess table" will be installed by the end of May, delivery of it will coincide with the completion of the base
- v) HARP is supporting other groups in the town to fulfil their aspirations
- vi) Minutes of HARP meetings will be available in the near future
