#### 5 Wildlife Area Hall Garth Park

Cllr K Nicholson spoke about a wildlife area being created in Hall Garth Park. The Deputy Clerk informed Cllr Nicholson that there was already a wildlife area situated within Hall Garth Park near Eastgate entrance and that a suggestion had been made from one of the workforce for a notice board to be produced pointing this area out to both residents and visitors. Following a discussion it was **RESOLVED** that a notice board be provided.

# 6 Hornsea Skate Park Close Out Report

Cllr A Robinson had supplied members with a full Replacement Skate Park 2018 Project Close Out Report for their approval before the report was sent to the fund providers. It was **RESOLVED** that a) the report be approved and b) thanks be given to Cllr Robinson for all his hard work and commitment given to the project.

# **7** Plastic Free Township

Cllr Ms J Kemp spoke to members regarding a Plastic Free Township. Cllr Kemp had attended their meeting as a representative of Hornsea Town Council during which discussions had taken place regarding the beach clean in July which had been a huge success. The cleaning of Stream Dyke and the grassed area surrounding it had also been discussed. Cllr Kemp was informed that permission must be obtained from Yorkshire Water, the Environment Agency and ERYC and that insurance would also need to obtained before any cleaning commenced, she was also informed that the Dyke already gets 2 full cleans per year one of which is due any time now. Cllr Kemp thanked members for their comments and will pass them on at the next meeting of the Plastic Free Township.

## 8 Application for use of Hall Garth Park 2019

A request had been received from Rob Prince to use Hall Garth Park during the school holidays and weekends throughout the year, weather permitting, to put a small food bar and bouncy castle in the area at the bottom end near to the children's play area to commence from Easter 2019. It was **RESOLVED** that Mr Prince would be invited to attend a meeting with members before the next Parks and Cemeteries meeting to discuss exactly what he is proposing, following which the working party would meet to discuss the request prior to any permission being granted.
