3 Clerk's Update

The Deputy Clerk had nothing to report.

4 Cyclocross Race Proposal – Hall Garth Park

A request had been received from Velo Club, Beverley who arrange a non profit making Cyclocross event annually as part of the Yorkshire points Cyclocross League and affiliated to British Cycling to hold an event in Hall Garth Park one Sunday during the Cyclocross season which runs from 1st September to January. It was **RESOLVED** that permission be refused as Hall Garth Park would not be the right location for this type of event due to the excessive wear and tear that would be caused on the park, but wished them every success in finding the right location.

5 Planet Circus 2017 – Hall Garth Park

A request had been received from Planet Circus to hold a circus in Hall Garth Park during August 2017. It was **RESOLVED** that permission be refused due to events already in place and possible development of the park.

6 **Dog fouling in Hornsea**

Stuart Allen, Senior Dog Warden for East Riding of Yorkshire Council sent an email informing the Town Clerk that in November 2016 a FPN was issued to a Hornsea resident for failure to clean up after their dog had fouled in Hall Garth Park, the £75 fine had been paid in full. **NOTED**

7 Roadside Verges

East Riding of Yorkshire Council contacted the Town Clerk regarding the areas of verge that had not been cut on a regular basis in an attempt to encourage wild flowers to grow on Trinity Road and Scalby Place. However, due to the poor amount of wildflowers now growing in the area they would like to know if the Council would be happy for them to keep the verges tidy by cutting on a more regular fortnightly schedule or leave them uncut during Summer and only cut them once a year. It was **RESOLVED** that East Riding of Yorkshire Council cut the verges on a fortnightly basis.

8 Mereside Children's Play Area

Councillor Mrs B Y Jefferson remarked on the fact that since the Civic Society had completed the initial clearing towards the Mere on Mereside nothing had been carried out since and as a result the area is once again becoming overgrown. She also raised the subject of the children's play area and felt that this should be fenced off. It was **RESOLVED** a) any grants available at the moment would be sourced b) that a member of the Sport & Play, ERYC would be invited to attend a meeting of the Parks & Playground Working Party to discuss a new scheme for the play area and c) that the Civic Society would be contacted for an update on Mereside.
