**4 Royal British Legion – VE Day Street Party – Use of Car Park and Surrounding Area**

A request had been received from the British Legion for use of the car park and surrounding area for the 75<sup>th</sup> anniversary of VE day street party on Saturday 9<sup>th</sup> May 2020. It was **APPROVED** that the request be granted.

**5 Use of Hall Garth Park – Scenic Tour of East Yorkshire**

A request had been received from North Humberside Motor Club Ltd. for the use of Hall Garth Park on Saturday 14<sup>th</sup> September 2019 as the half-way halt to have cars assembled together on display and to allow participants the opportunity to make use of the facilities in the local area for refreshments etc. It was **APPROVED** that the request be granted.

**6 Bus Stop Broadway**

Following on from the Town Council meeting regarding the concern for the Hail and Ride service currently being offered on Broadway the Town Clerk had been in contact with ERYC who had informed her that “if there is a bus stop along a street or a road there would not be a Hail and Ride service as one cancels the need for the other and vice versa”. Members were asked whether or not they would like to see a bus stop on Broadway, the Hail and Ride would still go along Parva Road and Sands Lane. It was **APPROVED** that the proposed bus stop not be erected on Broadway and the Hail and Ride service was to continue.
