6. Police attendance/information

A written report from the Police on recent crimes etc in Hornsea was circulated. Following concern being expressed regarding cycling on footpaths it was **RESOLVED** that the Police be asked for their view/comment on cyclists using footpaths. It was further **RESOLVED** that the Police be asked to clarify crime statistics in Hornsea during summer months

7. Town Clerk's Update

i) Hanging baskets – the Town Clerk informed members that the hanging baskets are looking extremely good this year, that there are now around 200 baskets around the town and that staff are unable to deal with any further additions to hanging basket numbers going forward. It was **RESOLVED** that an article regarding hanging baskets be placed in the Community News publication

ii) Parish Transport Champion – update – Cllr Andrew gave details of his conversation with the current Parish Transport Champion and confirmed that he will be the Town Council representative – **RESOLVED** noted with thanks to Cllr Andrew
