- \*20/00190 Fell 2 no. sycamore trees (1 and 2) due to close proximity to the property, roots at risk of causing damage if the trees are allowed to grow, and trees are causing shade and damp to the building at The Folly, The Willows, Hornsea - **RESOLVED** support the Tree Officer’s decision on this application
- \*20/00241 Fell 2 no. Cypress trees due to close proximity to the property at Grebe House, 27 Westgate, Hornsea - **RESOLVED** support the Tree Officer’s decision on this application
- 19/04257 Erection of single storey extension to side and installation of replacement window to rear at Risingfield, Strawberry Gardens, Hornsea – **RESOLVED** support

- 19/03704           Erection of three detached dwellings with associated works at Land North West of Burton House, Hornsea Burton Road, Hornsea – **RESOLVED** support
- 20/00070           Fell 1 no. Silver Birch tree due to poor condition, rot and low amenity value at Westgarth, Westwood Avenue, Hornsea - **RESOLVED** support the Tree Officer’s decision on this application
- 20/00188           Re-Pollard 1 no. Ash tree (T1) due to the tree suffering excessive amounts of heartwood rot in the main limbs leading from the bole and length and weight on the outer extremities at potential risk of failure at 2 The Rise, Hornsea - **RESOLVED** support the Tree Officer’s decision on this application
- 19/03860           Erection of a dwelling and construction of vehicular access and associated infrastructure at Land South of Sunnymount, Strawberry Gardens, Hornsea – The Town Clerk informed members that a number of objections had been received to this application and these were circulated. Following considerable discussion it was **RESOLVED** that this application NOT be supported due to:-
- i)        conflict with the existing pattern of development
  - ii)       poor relationship with adjoining buildings
  - iii)      visually damaging in the setting
  - iv)      conflict with the character of the area
  - v)       loss of historic street pattern
  - vi)      over looking adjoining properties
  - vii)     ultimate “back land” development
  - viii)    an unfortunate precedent will be set
- Hornsea Town Council feels strongly about this application and asks that, should the officer be recommending a different decision, the application be referred to the planning committee for consideration
