PART A – PECUNIARY INTERESTS

NB – In accordance with Section 34 of the Localism Act 2011, a person commits an offence if, without reasonable excuse, they fail to register their pecuniary interests within 28 days of taking office or fail to update their register within 28 days of a change of their pecuniary interests.

*Body in which any of the above named persons has a beneficial interest means a firm in which any of the above named persons is a partner or a body corporate of which any of the above named persons is a director, or in the securities of which any of the above named persons has a beneficial interest.
